If Borrower learns, or is notified by any government entity or regulatory authority, or any private party, that any removal or other remediation of any Hazardous Substance affecting the Property is necessary, Borrower shall promptly take all necessary actions in accordance with Environmental Law. Nothing herein shall create any obligation on a Lender for an Environmental Clean-up.

23. Release. Upon payment of all sums secured by this Security Instrument, Lender may release this Security Instrument, Borrower shall pay any recordation costs, and Lender may charge Borrower a fee for releasing this Security Instrument, but only if the fee is paid to a third party for services rendered and the charging of the fee is permitted under Applicable Law.

24. Waiver of Homestead. In accordance with Illinois law, the Borrower hereby releases all rights under and by virtue of the Illinois homestead exemption laws.

25. Placement of Collateral Protection Insurance. Unless Borrower provides Lender with evidence of the insurance coverage required by Borrower's Agreement with Lender, Lender may purchase insurance at Borrower's expense to protect Lender's interests in Borrower's real estate and waives all rights under and by virtue of the Illinois homestead exemption laws.


