- 2. On information and belief, on a date prior to December 2, 1999, the Owner, or one knowingly permitted by the Owner to do so entered into a contract with Contractor whereby the Contractor was to provide labor and materials for the improvement of the arroye described property.
- 3. On or about December 3, 1999, Contractor entered into a subcontract with the Lien Claimant for the improvement of said property. Pursuant to said subcontract, the Lien Claimant arranged and provided labor and materials for the improvement of said property as required by the contract and under the supervision and approval of the Contractor. Pursuant to said subcontract, the Lien Claimant provided labor and materials for the installation of certain heating, ventilating and air conditioning for said improvement in the amount of thirty-two thousand six hundred ninety-two dollars (\$32,692.00).
- On or about August 17, 2001, the Lien Claimant substantially completed all work under the subcontract and change order.
- 5. The Contractor is entitled to total credits as follows: twenty thousand six hundred fifty-four dollars (\$20,654.00), leaving due unpaid and owing to the Lien Claimant, after allowing all credits, the sum of twelve thousand thirty-eight dollars (\$12,038.00), for which, with interest, the Lien Claimant claims a lien on said land and improvement, and on the monies or other consideration due or to become due from the Owner under said contract between the Contractor and the Owner.
