SEVENTH AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS & COVENANTS FOR THE CRYSTAL CREST CONDOMINIUMS

WITNESSETH

WHEREAS, by the Declaration of Condominium Ownership recorded in the Office of the Recorder of Deeds of Cook County, Illinois as Document No. 00682981 on September 1, 2000 JOHN PACE BUILDERS, INC. submitted certain real estate to the Condominium Property Act of the State of Illinois (the "Act"), said Condominium being known as CRYSTAL CREST CONDOMINIUMS.

WHEREAS, under Paragraph 1 of ARTICLE XX of the Declaration, the right is reserved in the Declarant, JOHN PACE BUILDERS, INC. to annex and add certain real property to the Parcel and Property described in the Declaration, and thereby add to the Condominium; and



WHEREAS, the Additional Property is now improved with one (1) building containing four (4) units, making a total of four (4) additional units, as defined in the Declaration.

NOW THEREFORE, JOHN PACE BUILDERS, INC. and for the purpose above set forth, hereby declares that the Declaration be and hereby is amended as follows:

- 1. The Additional Property is hereby annexed to the Parcel and Property as defined in Article I of the Declaration and is hereby sugmitted to the provisions of the Act as a part of the Condominium in accordance with, and shall be deemed to be governed in all respects by the terms and provisions of the Declaration. The Additional Mand as now described is set forth herein as Exhibit "C".
- 2. The Plat attached to the Declaration as Exhibit "A" showing the boundaries of the Property and delineating and describing the Units contained therein, is hereby amended and supplemented by Exhibit "A" attached hereto showing the boundaries of the annexed Property and describing the additional units contained in said annexed Property.
- 3. Exhibit "B" attached to the Declaration setting forth the percentages of the undivided interest in the common elements corresponding to each Unit described in Exhibit "A" prior to this Amendment are hereby reduced to the respective percentage interest in the common elements as set forth in Exhibit "B" attached hereto. Exhibit "B" attached to the Declaration is amended by the substitution of Exhibit "B" attached hereto.
- 4. The additional common elements added to the Declaration by this Amendment are hereby granted and conveyed, all as set forth in the Declaration.
- 5. Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.
