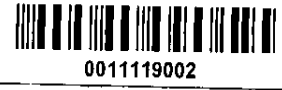
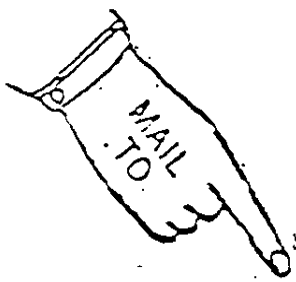

The Mortgagor is executing simultaneously herewith that certain mortgage, dated July 23, 2001 (the "Security Instrument") to secure a loan (the "Loan") made by HARRIS TRUST AND SAVINGS BANK (the "Lender") in the amount of \$95,950.00 to the Mortgagor, evidenced by a note (the "Note") of even date herewith. It is expected that the Loan will be purchased by the Illinois Housing Development Authority (the "Authority"). It is a condition of the making of the Loan that the Mortgagor execute this Rider.

In consideration of the respective covenants of the parties contained in the Security Instrument, and for other good and valuable consideration, the receipt, adequacy and sufficiency of which are acknowledged, Mortgagor and Lender further mutually agree as follows:
