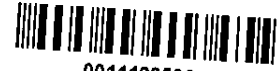




NOTICE OF LIEN

NOW COMES THE CITY OF EVANSTON, an Illinois municipal corporation, 200 Ridge Avenue, Evanston, Illinois 60201, by Stanley Janusz, Assistant Director, Property Standards/Housing Rehabilitation, and claims a lien in the amount of One Hundred Seventy Eight and No/100 Dollars (\$285.00). Said lien is claimed pursuant to the police powers of a home rule unit of local government to protect the public health, welfare, and safety and the occupants of a structure by closing and securing said structure when its condition imperils life, safety, or health. 


