WHEREAS, this amendment has been signed and acknowledged by at least 80% of the owners, said signatures attached hereto and made a part hereof; and

WHEREAS, notice of the amendment has been made to Eligible Mortgage Holders by mail, as certified on Exhibit B hereto.

Included in this mailing was a consent form





for first mortgagees to utilize, in the format attached hereto as Exhibit C. Said consent of an Eligible Mortgagee shall be deemed granted unless the Association is advised to the contrary in writing within 30 days after making the request for consent.

NOW, THEREFORE, the Association hereby declares that the Declaration be and is hereby amended as follows (additions to text are shown as <u>double underlined</u> and deletions to text are shown as a <u>strikeout</u>):

1. Article XI, Section A.1. of the Declaration shall be amended as follows:

A. <u>Sufficient Insurance</u>.

1. The Board of Directors shall acquire as a Common Expense, a policy or porcies of insurance insuring the Common Areas (excluding the Buildings) and the Buildings containing the Units ("Buildings") against loss or damage from fire, lightning and other hazards contained in the customary fire and extended coverage Vandalism and malicious mischief endorsements for the full insurable replacement value of the Common Areas and the Buildings in the name of and to require a provision in such policy that the proceeds thereof shall be payable to the members of the Board, as trustees for each of the Owners. Each Owner as of the effective of the of this Amendment shall be responsible for obtaining property damage, casualty and liability insurance for their Unit, including the full replacement cost. The Association shall no longer be responsible for providing insurance other than for the Common Areas. Each Owner shall provide a copy of a Certificate of Insurance to the Board of Directors reflecting comprehensive coverage.

2. Article XI, Section 4. of the Declaration shall be amended as follows:

4. <u>Appraisal</u>. The full, insurable replacement cost of the Property, including the Common Areas and Buildings shall be determined from time to time (but no less frequently than once in any twelve month period) by the Board.

The Board shall have the authority to obtain an appraisal by a equitable appraisal company as selected by the Board.

3. Article XI, Section 5. of the Declaration shall be amended as follows:

5. <u>Public Liability and Property Damage Insurance</u>. The Board of Directors shall acquire, as a Common Expense, comprehensive public liability insurance against claims and liabilities arising in connection with the ownership, existence, use or management of the Property in amounts deemed sufficient in the judgment of the Board of Directors, insuring the Developer and Owners, individually and severally, the Board of Directors, the Association, the

Management Agent, and their respective employees, agents and all persons acting as agents. The Developer shall be included as an additional insured in his capacity as Owner and Board member. The Owners shall be included as additional insureds but only with respect to that portion of the premises not reserved for their exclusive use. The insurance shall cover claims of one or more insured parties against other insured parties. The insurance shall contain a waiver of any rights to subrogation by the insuring company against any of the above named insured persons.

4. Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.


