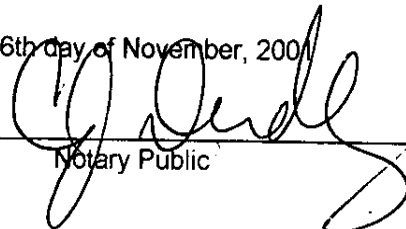

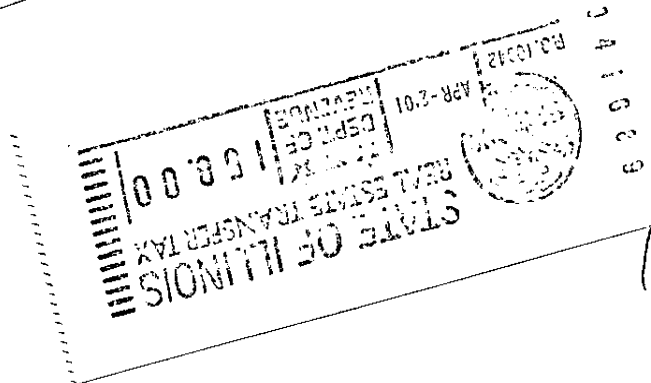
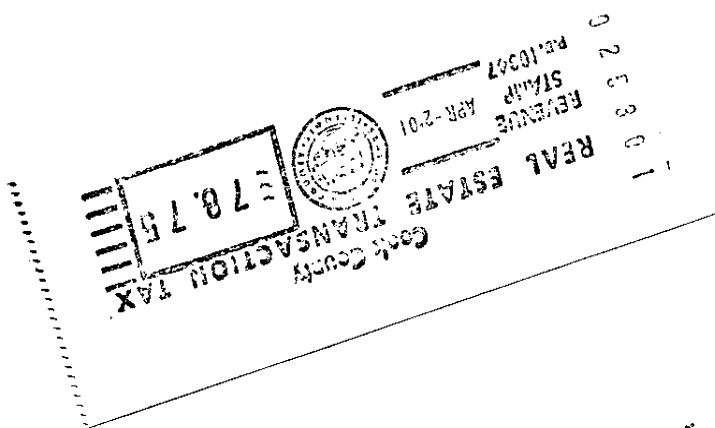
Legal Description
