ORIGINAL CONTRACTOR'S CLAIM FOR MEHCANIC'S LIEN

The claimant, Keller Electric, Inc., an Illinois corporation ("the claimant") with address of 244 Apollo Court, Wood Dale, Illinois 60191, hereby files its original contractor's claim for mechanic's lien upon the real estate located in Cook County, Illinois commonly known as 4715 25 North Lincoln Avenue, Chicago, Illinois and all of the improvements thereupon (hereinafter collectively referred to as "the real estate"), and against the interest in the real estate of Roger E. - 1. On or about March 11, 2000 and subsequently, owner owned fee simple title to the real estate and all of the improvements thereupon.
- 2. On or about March 11, 2000, claimant entered into a contract ("the contract") with Larry Jones ("Jones") pursuant to which claimant agreed to provide all necessary labor and material to install electrical conduit, equipment, fixtures, appliances and supply at the real estate in exchange for owner's payment to claimant of claimant's usual hourly rate of compensation for electrical contracting services.
- 3. The contract was entered into by Jones as owner's agent, and the work was performed with the knowledge and consent of owner. Alternatively, owner authorized Jones to enter into the contract. Alternatively, owner knowingly permitted Jones to enter into the contract for the improvement of the real estate.

4. Claimant last performed work pursuant to the contract on January 8, 2001.

5. As of the date hereof, there is due, unpaid and owing to claimant, after allowing all credits, the principal sum of \$22,556.04, which principal sum bears interest at the statutory real estate in the amount of \$22,556.04 plus interest.
