virtue hereof.

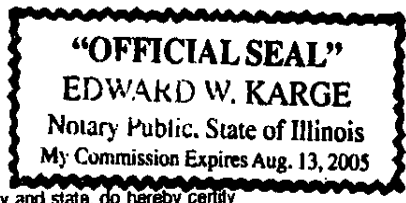
I hereby agree and represent to those persons dealing with my agent and attorney-in-fact that this power of
