THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 2.

- 1. Mortgagors shall (1) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (2) keep said premises in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien not expressly subordinated to the lien thereof; (3) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to the Mortgagee; (4) complete within a reasonable time any building or buildings now or at any time in process of erection upon said premises; (5) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (6) make no material alterations in said premises except as required by law or municipal ordinance.
- 2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to the Mortgagee duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or asssessment which Mortgagors may desire to contest.
- 3. All moneys paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, including actorney's fees, and any other moneys advanced by Mortgagee to protect the mortgaged premises and the lien hereof, shall be so much additional indebtedness secured hereby and shall become immediately due and payable without notice and with interest thereon at the highest rate now permitted by Illinois law. - 10. When the indebtedness hereby shall become due whether by acceleration or otherwise, Mortgagee shall have the right to foreclose the lien hereof. In any suit to foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures and expenses which may be paid or incurred by or on behalf of Mortgagee for attorneys' fees, appraiser's fees, outlays for documentary and expert evidence, stenographers' charges, publication costs and costs (which may be estimated as to items to be expended after entry of the decree) of procuring all such abstracts of title, title searches, and examinations, title insurance policies, Torrens certificates, and similar data and assurances with respect to title as Mortgagee may deem to be reasonably necessary either to prosecute such suit or to evidence to bidders at any sale which may be had pursuant to such decree the true condition of the title to or the value of the premises. 11. The proceeds of any foreclosure sale of the premises shall be distributed and applied in the following order of priority. First, on account of all costs and expenses incident to the foreclosure proceedings, including all such items as are mentioned in the preceeding paragraph hereof; second, all other items which under the terms hereof constitute secured indebtedness additional to that evidenced by the note, with interest thereon as herein provided; third, all principal and interest remaining unpaid on the note; fourth, any overplus to Mortgagors, their heirs, legal representatives or assigns, as their rights may appear.

12. Upon or any time after the filing of a complaint to foreclose this mortgage the court in which such complaint is filed may appoint receiver of said premises. Such appointment may be made either before or after the sale, without notice, without regard to the solvency or insolvency of Mortgagors at the time of application for such receiver and without regard to the then value of the premises or whether the same shall be then occupied as a homestead or not, and the Mortgagee may be appointed as such receiver, Such receiver shall have power to collect the rents, issues and profits of said premises during the pendency of such foreclosure suit and, in case of a sale and a deficiency, during the full statutory period of redemption, whether there be redemption or not, as well as during any further times when Mortgagors, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the premises during the whole of said period. The Court from time to time may authorize the receiver to apply the net income in his hands in payment in whole or in part of: (1) The indebtedness secured hereby, or by any decree foreclosing this mortgage, or any tax, special assessment or other lien which may be or become superior to the lien hereof or of such decree, provided such application is made prior to foreclosure sale; (2) the deficiency in case of a sale and deficiency.

13. No ction for the enforcement of the lien or of any provision hereof shall be subject to any defense which would not be good and available to the party interposing same in an action at law upon the note hereby secured.

14. The Mo.rg. gee shall have the right to inspect the premises at all reasonable times and access thereto shall be permitted for that purpose.


15. The Mortgage shall periodically deposit with the Mortgagee such sums as the Mortgagee may reasonably require for payment of taxes and assessments on the premises. No such deposit shall bear any interest.

16. If the payment of air indebtedness or any part thereof be extended or varied or if any part of the security be released, all persons now or at any time hereafter liable therefor, or interested in said premises, shall be held to assent to such extension, variation or release, and their liability and the lien and all provisions hereof shall continue in full force, the right of recourse against all such persons being expressly reserved by the Mortgagee, notwithstanding such extension, variation or release.

- In addition to the monthly payments of principal and interest due under the note secured by this Mortgage, the Mortgagee may, at its option, require Mortgagors to deposit with the Mortgagee, at the same time each monthly payment of principal and interest is due, 1/12th of the annual real estate taxes as estimated by the Mortgagee. If Mortgagee exercises such option, Mortgagee shall mail Mortgagors a notice that Mortgagee is exercising such option. Mortgagee shall use these deposited funds to pay the general real estate taxes. These funds are hereby pledged as additional security to the Mortgagee for the payment of the real estate taxes and the principal balance and interest on the note remaining unpaid from time to time. Mortgagee shall not be required to pay interest on these funds. amount of the funds held by the Mortgagee shall not be sufficient to pay all the real estate taxes as herein provided, then within fifteen (15) days from the date rolice is mailed by Mortgagee to Mortgagors requesting payment thereof, Mortgagors shall pay to Mortgagee the amount necessary to make up the deficiency.
- 20. If all or any part of the premises or any interest in it is sold, conveyed or transferred without Mortgagee's prior written consent, Mortgagee may, at its option, require immediate payment in full of all sums secured by this Mortgage. However this option shall not be exercised by Mortgagee if exercise is prohibited by rederal law as of the date of this Mortgage. If Mortgagee exercises this option, Mortgagee shall give Mortgagors notice of acceleration. The notice shall provide a period of not less than 30 days from the date the notice is delivered or mailed within which Mortgagors must pay all sums secured by this Mortgage. If Mortgagors fail to pay these sums prior to the expiration of this period, Mortgagee may invoke any remedies permitted by this Mortgage without further notice or demand on Mortgagors.
- 21. Mortgagors shall not cause of permit the presence, use, disposal, storage or release of any Hazardous Subscences on or in the premises. Mortgagors shall not do, nor allow anyone else to do, anything affecting the premises that is in violation of any Environmental Law. If Mortgagors learn, or are notified by any governmental or regulatory authority, that any removal or other remediation of any Hazardous Substance affecting the premises is necessary, Mortgagors shall promptly take all necessary remedial actions in accordance with Environmental Law.

As used in this paragraph 21, "Hazardous Substances" are those substances defined as toxic or hazardous substances by Environmental Law and the following substances: gasoline, kerosene, other flammable or toxic petroleum products, toxic pesticides and herbicides, volatile solvents, materials containing asbestos or formaldehyde and radioactive materials. As used in this paragraph 21, "Environmental Law" means federal laws and laws of the state, county, and local jurisdiction where the premises is located that relate to health, safety or environmental protection.

22. Diann D. Sheridan is not a party to the Promissory Note of even date herewith that is secured by this Mortgage. However, Mortgagee would not have made or renewed the loan evidenced by the Promissory Note that is secured by this Mortgage if Dianne D. Sheridan had not agreed to execute this Mortgage. Diann D. Sheridan is executing this Mortgage to waive any and all marital and homestead rights she may have in and to the premises and agrees to be bound by and comply with the terms and provisions of this Mortgage.
