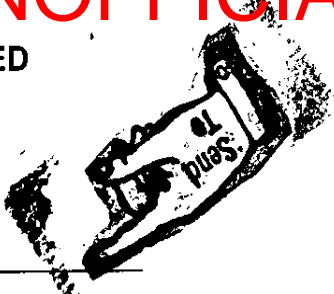

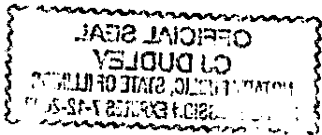


Exhibit A
