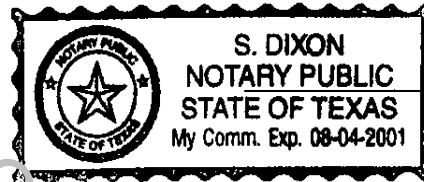

## EXHIBIT "A"
