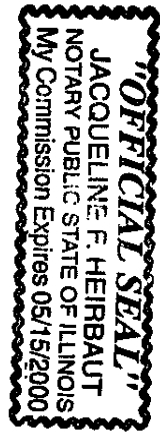

PARCEL 1:

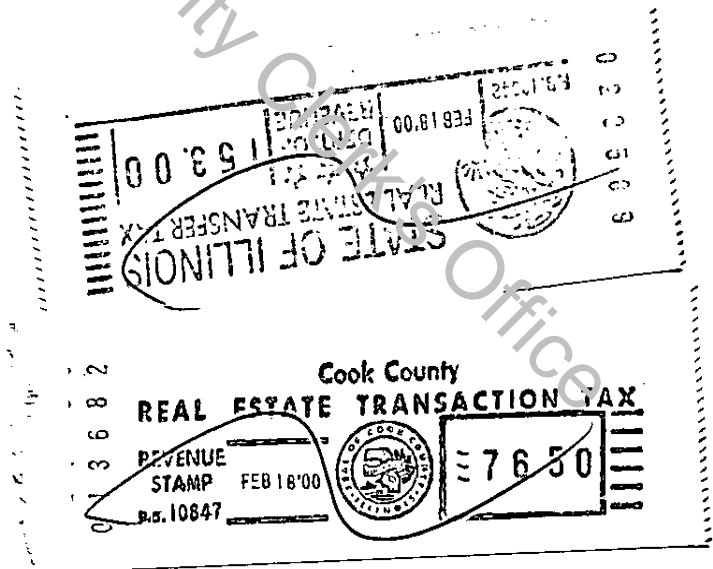
