AMENDMENT TO HOME EQUITY LINE OF CREDIT AGREEMENT AND MORTGAGE

THIS AMENDMENT, made this 13th day of December, 1999, by and between American National Bank & Trust Co. of Chicago, as Trustee Under Trust Agreement dated 08/02/91, and known as Trust #114322-00, as Borrower under the hereinafter described Credit Agreement and the hereinafter described Mortgage (hereinafter referred to as the "Borrower"), and Plains Pank of Illinois, N.A. NOW, THEREFORE, all other good and valuable consideration, receipt of which is hereby acknowledged, and in further consideration of the mutual promises herein, the Borrower and the Bank agree as follows:

- 1. The foregoing preambles are hereby made a part hereof.
- Maturity Date, Draw Period and Repayment Period (as such terms are defined in the Credit Agreement) pursuant to the terms and conditions of the Credit Agreement are hereby extended to December 13, 2004. The Credit Agreement and the Mortgage are hereby amended to reflect this charge.
- 3. All terms, provisions and conditions of the Credit Agreement and the Mortgage not amended hereby are hereby confirmed.
