### FIRST AMENDMENT

## TO DECLARATION OF CONDOMINIUM

### FOR THE LAKE COURTS CONDOMINIUM

THIS DECLARATION made and entered into this 25<sup>th</sup> day of February, 2000, by and between **AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO**, not personally, but solely as Trustee Under Trust Agreement dated June 17, 1998, and known as Trust Number 124218-06 (the "Trustee") and **OPTIMA WILMETTE WEST LIMITED PARTNERSH!P**, an Illinois limited partnership (the "Developer").

### WITNESSETH:

WHEREAS, by a Declaration of Condominium (the "Declaration") recorded in the Office of the Recorder of Decis of Cook County, Illinois, as Document Number 00079644, on January 31, 2000 the Trustee submitted certain real estate to the provisions of the Illinois Condominium Property Act (the "Act"); and,

WHEREAS, the Declaration reserves to the Trustee and the Developer (as defined in The Declaration) the right to annex and add to the Parcel (as defined in the Declaration) and thereby add to the Condominium created by the Declaration all or any portion of the Future Development Parcel (as defined in the Declaration); and,

WHEREAS, the Trustee at the direction of the Developer now desires to so annex and add to the Parcel and submit to the provisions of the Act and the Declaration certain real estate (the "Additional Parcel") described in Exhibit "A-1" attached hereic, which Additional Parcel is a portion of the said Future Development Parcel.

NOW, THEREFORE, the Trustee does hereby amend the Declaration as follows:

- 1. The Additional Parcel (as described in Exhibit "A-1" attached hereto) is licreby annexed to the Parcel as defined in the Declaration, and is hereby submitted to the provisions of the Act as a part of the Condominium in accordance with and shall be deemed to be governed in all respects by, the terms and conditions of the Declaration.
- 2. Exhibit "B" of the Declaration is hereby amended by deleting pages 1, 4, 5, 6 of Exhibit "B" to the Declaration and substituting therefore pages 1, 4, 5, 6 attached hereto.
- 3. Exhibit "C" of the Declaration is hereby amended by deleting said Exhibit "C" and substituting therefore Exhibit "C" which is attached hereto. The Percentage of Ownership in the Common Elements appurtenant to each Unit are hereby shifted to the percentages set forth in the Exhibit "C" which is attached hereto.

- 4. The Additional Common Elements and Limited Common Elements are hereby granted and conveyed to the grantees of all Units, including the grantees of Units heretofore conveyed, all as set forth in the Declaration.
- 5. Except as expressly set forth herein, the Declaration shall remain in full force ar **Q0148134** effect in accordance with its terms.
- 6. This instrument is executed by AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO, not personally, but solely as Trustee as aforesaid, in the exercise of the power and authority conferred upon and vested in its as such Trustee.
