I hereby artify that a (regular)(annual)(special) meeting of the (directors)(members) of PREFERRED SERVICE CREDIT UNION, held on the 20 to day of A.D. 20 oo, pursuant to the notice required by Article XXI, of the ByLaws of the said Credit Union and by Section 305/4 of "The Illinois Credit Union Act," approved August 30, 1970, and in force on January 1, 1980, as amended, the following Resolution was adopted:

RESOLVED: THAT ARTICLE V - DIRECTORS - OF THE BYLAWS OF THIS CREDIT UNION BE AMENDED TO READ AS FOLLOWS:

Section 1(b).

The number of directors of this credit union shall be 12. Directors shall be elected at each annual meeting of the members held in accordance with Article IV of these bylaws. Directors shall be divided into 3 (2 or 3) classes with each class as nearly equal in number as possible. The first class shall consist of 4 directors, the second class shall consist of 4 directors and the third class shall consist of 4 directors (if applicable). The term of office of the directors of the first class shall expire at the first annual meeting after their election, that of the second class shall expire at the second annual meeting after their election and that of the third class, if any, shall expire at the third annual meeting after their election. At each annual meeting after the classification, the number of directors equal to the number of directors whose term expire at the time of the meeting shall be elected to hold office until the second succeeding annual meeting if there are 2 classes or until the third succeeding annual meeting if there are 3 classes. The directors, unless sooner disqualified or removed, shall hold office for the term for which elected and until their successors are elected and shall have been qualified.


