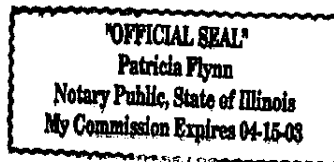
AND KNOW THEREFORE, it is hereby agreed that said mortgage and supplement thereto, and any obligation or obligations secured thereby, be and the same are hereby modified, altered and amended in a manner so that JOHN H. MILLER, thereby agrees to pay LIBERTY FEDERAL BANK, its successors and assigns, the amount remaining unpaid on said mortgage indebtedness in the sum of FIFTY-ONE THOUSAND ONE HUNDRED AND NO/100 (\$51,100.00), with interest calculated on the outstanding balance at the rate of Prime Plus 1.0% for the remaining term of the loan as was stated in the original promissory note dated MAY 29, 1999. 


