ORDER OF PERMANENT INJUNCTION

This matter coming on to be heard on the regular trial call and on motion of plaintiff, City of Chicago, and the court having jurisdiction over the parties and subject matter and having been fully advised in the premises, the court orders:

1. Defendant(s) BROWN CATALINA his/her/their agents, heirs, successors or assigns, are permanently enjoined and restrained from renting, leasing, using or occupying the 5129 S. LAFLIN of the subject premises until full compliance with City of Chicago codes as stated in this cause and full compliance must be completed on or before \_\_\_\_\_ or further order of court.

2. Defendant shall schedule and permit interior inspections of the building to verify compliance with the terms of this order. Defendant shall call the inspector at 744-\_\_\_\_\_ or send written request to the Department of Buildings within 7 days after the compliance date stated in this order.

3. The court reserves jurisdiction of this matter for the purposes of modification, enforcement or termination of this permanent injunction, including the adjudication of contempt proceedings if the permanent injunction is violated which could result in the imposition of a fine up to \$500 per day/or incarceration for not more than 180 days until the contemnor complies.

4. This order is final and appealable, the court finding no just cause or reason to delay its enforcement or appeal.
