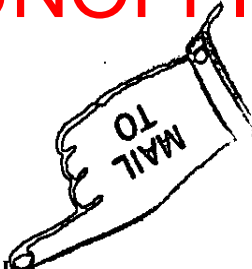

That on **July 15, 1999** owner owned the following described land in the County of Cook, State of Illinois, Property Index Number: **05-33-107-059-0000** legally described as:

*That part of the north west 1/4 of the north west 1/4 of section 33, township 42 north, range 13, east of the third principal meridian, described as follows:
Commencing at a point in the east line of said north west 1/4 of the north west 1/4, 122.33 feet north of the south east corner of said north west 1/4 of the north west 1/4 and running thence north 284.67 feet along said east line; thence west parallel to south line of the said north west 1/4 of the north west 1/4, 123.17 feet; thence south parallel to east line of said north west 1/4 of the north west 1/4, 284.67 feet; thence east 123.17 feet to the point of beginning, (except the west 54.585 feet and except the south 50.0 feet thereof) in Cook County, Illinois more commonly known as 2101 Birchwood Avenue Wilmette, Illinois, 60091.*





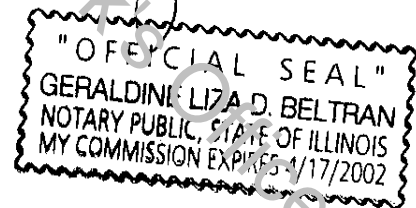
