SUBORDINATION

WHEREAS, Charles E. Woodruff and Janet M. Woodruff, husband and wife, hereinafter referred to as "Borrowers", are presently indebted to the U. S. WHEREAS, the said Note is secured by, among other things, that certain Mortgage executed by said Borrowers in favor of the Administrator of the SBA dated Frontary 1, 1994, and recorded as Document No. 94-138453 on February 14, 1994, AND, that certain Modification of Mortgage dated June 6, 1994 executed by said Borrowers in favor of the Administrator of the SBA dated June 6, 1994, and recorded as Document No. 94-501250 on June 6, 1994, BOTH in the office of the Recorder of Cook County, Illinois;

WHEREAS, said Borrowers are desireus of obtaining an additional loan in the amount of \$181,000.00 from CIT GROUP, hereinafter referred to as "Lender", for the purpose (f'retinancing Borrowers' first mortgage and to obtain funds for home improvement; and,

WHEREAS, the Lender requires the Borrowers to secul, said loan with a Mortgage on the real estate herein described, to wit:

The South 11 feet of Lot 11 and Lot 12 (Except the South 4 Feet The Feet in Block 7 in Gale and Welch's Resubdivision of Blocks 27 to 30 and Lots 4 to in Block 31 and all of Blocks 46 to 50 inclusive, in the Southeast 1/4 of Section 31 and Southwest 1/4 of Section 32, Township 40 North, Range 13, East of the Third Principal Meridian, in Cook County, 12 ocic.

and further requests that SBA subordinate its Mortgage to that Mortgage having been taken or to be taken by said Lender; which said Mortgage is recorded as Document No.______.

NOW THEREFORE, in and for good and valuable consideration, and in order to induce said London to make said loan to said Borrowers, SBA does herewith subordinate its Mortgage, to that Mortgage taken or to be taken by the Lender. Which secures said loan.

IT IS EXPRESSLY AGREED AND UNDERSTOOD, HOWEVER, that neither this Subordination, not anything contained herein shall in any wise alter or affect the validity of the Mortgage or the amendments thereto of SBA first mentioned nerein, or the lien on the real estate so subordinated herein, or any of the other collateral securing the indebtedness of the Borrowers to the SBA.

IT IS FURTHER EXPRESSLY AGREED AND UNDERSTOOD that this Subordination is to extend only to the amount of the current loan made to the Borrowers, for the purpose or purposes expressly set forth herein; and will not be valid for or extend to any future advances by Lender to Borrowers, on the Note evidencing Lender's loan. This clause, however, is NOT intended to prevent or inhibit advances by Lender for expenses incidental to the preservation of its collateral, protection of its security interest, collection of its debt, and/or the like.

IN WITNESS WHEREOF, the Administrator has caused this Subordination agreement to be executed by John Ben Bancroft, Center Counsel, on November 28, 2001, at Birmingham, Alabama, pursuant to the delegation of authority contained in Delegation of Authority, No. 12-D, Revision 3, Redelegation of Disaster Assistance, published in the Federal Register, Vol. 58, No. 206, page 57891, October 23, 1993.
