

NOTE MODIFICATION AGREEMENT

Lakeside Bank (the "Lender"), an Illinois Banking Corporation, and the undersigned, Raymond W. Horn and Paula M. Horn (the "Borrowers"), agree as follows:

- 1. The Lender presently owns and holds BORROWERS' Powerhouse Note, dated October 26, 2001 and payable to the Lender in the sum of \$237,500.00. The note is executed by Raymond W. Horn and Paul M. Horn (the "Borrowers") in their capacity as prime obligors on the note.
- 2. The note is secured by, among other things, a mortgage of same date conveying the premises commonly known as 630 Blackhorn Road, Winnetka, Illinois. The mortgage was recorded with the Cook County Recorder of Deeds on NOVEMBER 13, 2001 as Document Number 0011064078 and securing the real estate described in attached Exhibit "A". The Note, Mortgage, and all other documents evidencing or securing the Loan (the "Loan Documents") are hereby incorporated herein by reference
- 3. The Borrowers have requested and the Lender has agreed through terms of the Loan be modified. Accordingly, but subject to the conditions hereinatter provided, the Note and Mortgage (and each of the other Loan Documents to the extent necessary to conform thereto) are hereby amended as follows:
 - (a) The line has been reduced (from \$237,500.00) to \$220,000.00.
- 4. The Borrowers hereby warrant to the Lender that the title to the Premises and the priority of the Lien are in the same condition and subject to no exceptions other than as shown in the Loan Policy, except that the real estate taxes are currently paid and the Premises are free and clear from any mechanics (or other) liens with respect to any construction work thereon.

5. The foregoing modification shall be effective as of the date hereof, all other provisions shall remain in full force and effect; the execution hereof by the Borrowers shall also constitute its direction upon the land trust to execute such documents reflecting this modification as the Bank may deem necessary or appropriate hereto.
