The concentrations of chlorophyll *a* and chlorophyll *b* were calculated using the following equations: Chlorophyll *a* (mg g<sup>-1</sup>) = 12.7 (OD<sub>663</sub> - 3.27 OD<sub>646</sub>), Chlorophyll *b* (mg g<sup>-1</sup>) = 22.9 (3.27 OD<sub>646</sub> - OD<sub>663</sub>).


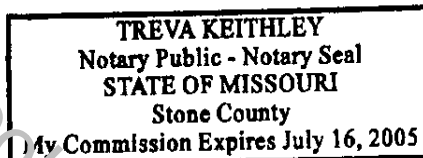
