FIRST AMENDMENT TO THE DECLARATION OF CONDOMINIUM FOR 1114 N. PAULINA CONDOMINIUM

This document is recorded for the purpose of amending the Declaration of Condominium (hereafter referred to as "Declaration") for 1114 N. Paulina Condominium"), which Declaration was made and entered into by Petru Cladovan ("Developes") and recorded on December 30, 1998, as Document No. 08188035 in the Office of the Recorder of Deeds of Cook County, Illinois against the Property (hereafter referred to as "roperty") legally described in Exhibit 1 attached hereto.

This Amendment is adopted pursuant to the provisions of Article XII, Paragraph 10 of the Declaration which provides a method to change or modify the condominium Declaration.

RECITALS

WHEREAS, by the Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been submitted to the provisions of the Illinois Condominium Property Act; and

WHEREAS, Article XII, Paragraph 10 of the Declaration provides, procedure for amending the Declaration to make any changes or modifications to the Declaration; and

WHEREAS, this Amendment has been made and approved by the Owners of the Units.

NOW THEREFORE, the Declaration for 1114 N. Paulina Condominiums is hereby amended in accordance with the text which follows (additions in text are indicated by underline; deletions by strike outs):

Amendment 1.

The Plat of Survey is being re-recorded to correct the designation of unit numbers on said Plat. The original plat erroneously mislabeled the unit numbers and the new Plat makes corrections to said designations.

Amendment 2.

ARTICLE II DESCRIPTION OF UNITS

1. <u>Description</u>. All units located on the property are delineated on the survey, referred hereto as Exhibit "D" and made a part of the Declaration and are legally described as follows:

Unit 1, Unit 2, Unit 2 and Unit 4 Unit 1F. Unit 1R. Unit 2 and Unit 3 in 1114 N. Paulica Condominiums as delineated on a survey of the following described real estate:

The North 1/2 of Lot 16 in Block 3 in Johnston's Subdivision of the East 1/2 of the Southeast 1/2 of Section 6, Township 39 North, Range 14, East of the Third Principal Mendian, in Cook County, Illinois.

which survey is attached as Exhibit "D" to the Declaration of Condominium recorded in the office of the Recorder of Deeds of Cook County, Illinois.

It is understood that each unit consists of the space enclosed or bounded by the horizontal and vertical planes set forth and identified as a unit in the delireation thereof in Exhibit "D". The legal description of each unit shall consist of the identifing number or symbol of such unit followed by the legal description of the Property, as shown on Exhibit "D". Except as provided by the Act, no Unit Owner shall, by deed, plat or otherwise, subdivide or in any other manner cause the unit to be separated into any tracts or parcels different from the whole unit as shown on Exhibit "D".

2. Certain Structures Not Constituting Part of a Unit. If any chutes, flues, ducts, conduits, wires, bearing walls, bearing columns, or any other apparatus lies partially within and partially outside of the designated boundaries of a unit, any portions thereof serving only that unit shall be deemed a part of said unit, while any portions thereof serving more than one unit or any portion of the common elements shall be deemed a part of the common elements.

Amendment 3.

ARTICLE X DESCRIPTION OF UNITS AND PARKING SPACES

a. All Units, including limited common element parking units, are delineated on the Plat attached herto as Exhibit D and made a part of this Declaration. The legal description of each Unit shall consist of the indentifying number or symbol of such Unit as shown on the Plat. Said Units are legally described on Exhibit A attached hereto and made a part hereof. Each of the Condominium Units shall have the following assigned limited common element parking units:
