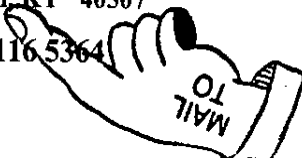

SUBORDINATION OF MORTGAGE

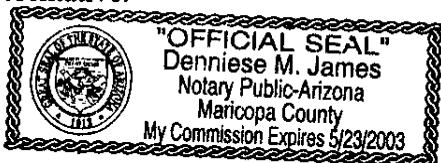
