Whereas, Borrower is indebted to Lender under that certain FlexEquity Account Promissory Note dated January 11, 2002 (herein "Note") with a credit limit of Ten Thousand Dollars and no / 100 dollars (\$ 10,000.00) (a minimum amount of \$10,000.00) of which an initial advance of XXXXXXXXXXXXXXXXXX XXXXXXXX XXXXXXXX XXXXXXXX has been made and against which Borrower may draw and Lender is obligated to make advances from time to time to the full amount thereof. 
