MODIFICATION AND EXTENSION AGREEMENT

THIS AGREEMENT made as of this 1st day of November, 2001 between REPUBLIC PANK OF CHICAGO, an Illinois banking corporation, hereinafter called Bank, and Republic Bank of Chicago, not personally but as Trustee under a certain Trust Agreement dated August 10, 1995 and known as Trust Number 1349, Joliet Kitchens and Baths, Inc., an Illinois corporation, and James Denos, the Owners of the property and/or the Obligors under the Note and hereinafter both called Second Party, WITNESSETH:

Furthermore, in order to induce Bank to enter into this agreement and for other good and valuable consideration, the receipt and sufficiency of which is her by acknowledged, Second Party does hereby release, remise and forever discharge Bank chand from any and all setoffs, claims, counterclaims, demands, causes, causes of action, stats and/or judgments which it now has or may have against Bank including but not limited to matter arising out of the Note and/or any document, instrument or agreement securing the same or arising out of any banking relationship existing between the parties.
