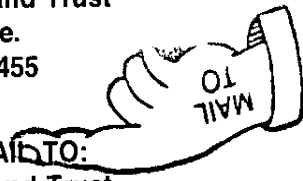

MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated December 12, 2001, is made and executed between Raymond V. McElree and Josie L. McElree, in joint tenancy, whose address is 15015 Avenida Del Este, Orland Park, IL 60462 (referred to below as "Grantor") and Bridgeview Bank and Trust, whose address is 7940 S. 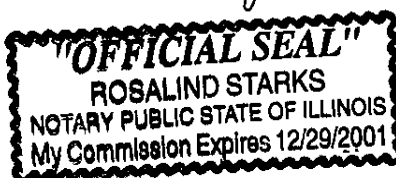
