Whereas, Assignor has conveyed, transferred, set over and assigned to Assignee a certain \$112,500.00 Mortgage and Note made by WMC Mortgage Corporation, to Shmuel E. and Dina B. Gulevsky (the "Borrower") all collateral for such loan, together with all mortgages, assignments, security agreements and other documents and instruments evidencing or securing such loan (collectively, the "Loan Documents"); and

Whereas, the Loan Documents include, without limitation, a Mortgage dated as of December 22nd, 1997, made by Borrower, as mortgagor, in favor of WMC Mortgage Corporation, as mortgagee (the "Mortgage"), recorded against the real property owned by Borrower and commonly known as 5127 N. Drake, Chicago IL 60625 (together with all improvements thereon, the "Premises"), as Document No. 98317255 in the office of the Cook County Recorder's Office, and then subsequently assigned to Universal Securities & Lending Services, Inc. as Doc. # 00786684 and then assigned to Philip and Darleen Bucaro as Doc# 0011032415 in the office of the Cook County Recorder's Office, which Premises are Legally described in Exhibit A attached hereto and incorporated herein by reference;

NOW THEREFORE, in consideration of ten dollars (\$10.00) the Premises and for good and valuable consideration in hand paid, the parties hereto hereby agree as follows:

1. Assignor does hereby sell, assign, transfer and set over to Assignee, without recourse to Assignor, all of Assignor's right, title and interest, of every kind and nature, in and to the Mortgage and the Premises.

The term "Lender" as used in the Mortgage, shall be hereafter deemed to mean Universal Securities and Lending Services, Inc. (as assignee of Philip and Darleen Bucaro.).

2. Assignor agrees that at any time and from time to time, upon the written request of the Assignee, it will promptly and duly execute and deliver any and all such further instruments and documents as are reasonably necessary to effectuate this assignment.

3. Assignor will promptly send copies of all notices and summons that Assignor receives with respect to the Mortgage or the Premises, to the Assignee at the address set forth in Section 4 below.

4. Any notice or summons required or desired to be given to the Lender pursuant to or with respect to the Mortgage shall be addressed to Assignee and sent to the following address:

6. This Assignment shall be binding on Assignor, its successors and assigns, and all persons claiming under or through any of the foregoing, and shall inure to the benefit of the Assignee, its successors, and assigns.

7. Assignor warrants and represents to Assignee that: (a) Assignor has full right, power, and authority to enter into this Assignment; and (b) Assignor's execution and delivery of this Assignment, and its assignment and transfer of the Mortgage to Assignee, constitutes the legal, binding and enforceable obligations of Assignor.

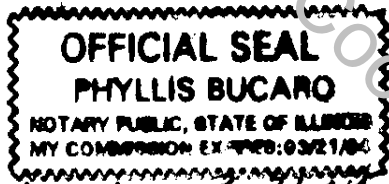

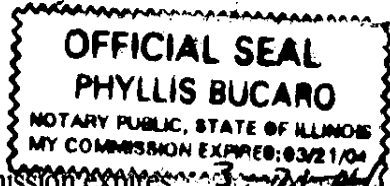
