

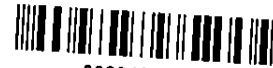

MODIFICATION OF MORTGAGE

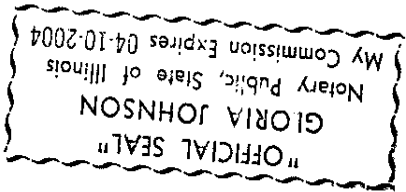
