4. At the special instance and request of Subcontractor, Lien Claimant furnished extra and additional materials to and extra and additional labor for said premises in the amount of \$333,132.66;

5. On October 18, 2001, lien claimant substantially completed labor to the value of \$1,022,132.66;

6. Owner, or the agent, architect or superintendent of Owner does not reside in said County;

On information and belief, the labor, materials, supplies, equipment and services for said work and in the improvement of the aforementioned premises performed and supplied by Lien Claimant was done with the knowledge and consent of the Owner of the beneficial interest in the above named Trust holding record title to the premises;

8. Subcontractor is entitled to credits on account thereof as follows: \$785,369.49 leaving due, unpaid and owing to Lien Claimant, after allowing all credits, the sum of \$236,763.17 for which, with interest, Lien Claimant claims a lien on the premises and improvements and to monies or other considerations due or to become due from Owner under said contract between General Contractor and Owner;

9. Notice has been duly given to Owner, and persons otherwise interested in the above described real estate, as to the status of the undersigned as subcontractor as provided by The Mechanics Lien Act (Ill. Rev. Stat. ch. 82, 5 and 24 (1991); 770 ILCS 60/5 and 60/24 (1992).

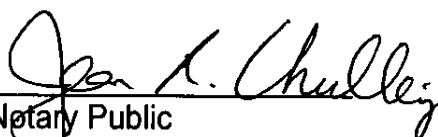
