Exhibit A Legal Description

Block 11 in South Branch Addition to Chicago in the North West 1/4 of Section 28, Township 39 North, Range 14, East of the Third Principal Meridian, except part of said block taken for widening of Archer Avenue; except Lots 6 to 9, inclusive, in said Block 11; and also except that part of lot 5 in said Block 11, that part of Lots 8 to 13. inclusive, and that part of the vacated alley lying Southerly of and adjoining to said Lot 5, which lies Southwesterly of a straight line that extended from a point on the South line of said Lot 8, which point is 186 feet West of the West line of South Wallace Street; thence to a point in said Lot 5, which point is on the Souther v line of South Archer Avenue. as widened, and is 228 feet Southwesterly of the intersection of the Westerly line of South Wallace Street and the Southerly line of South Archer Avenue, as widened, in H.
