SUBORDINATION AGREEMENT

THIS AGREEMENT is entered into this 4th day of December 2001, by WELLS FARGO HOME MORTGAGE (the Lender) and Ball West Credit Union (Lienholder).

Recitals

The Lender will provide credit to refinance the first mortgage secured by the Property if Lienholder subordinates its second mortgage lien to the Lender's new first mortgage lien.

NOW THEREFORE, in consideration of the covenants contained herein, the parties agree as follows:

1. Subordination. Lender agrees to and hereby does subordinate its second mortgage lien in the Property to a new first mortgage lien to be filed by the Lender in order to refinance its existing first mortgage.

2. Effect. The Lender agrees that Lender's second mortgage shall in no way be impaired or encumbered by this Agreement except that the second mortgage lien shall stand junior and subordinate to the Lender's new first mortgage in the same manner and to the same extent as if the Lender's new first mortgage had been filed prior to the execution and recording of the Lender's second mortgage.
