#### MODIFICATION AND EXTENSION AGREEMENT

- 1. The maturity date of the Note and Mortgage is hereby extended from December 15, 2004 to January 15, 2009.
- 2. The rate of interest charged under the Note shall be changed to 6.75% with installments of principal and interest based on a 20 year amortization schedule.

Second Party warrants and certifies that the indebtedness evidenced by the Note is a valid and subsisting debt of the Obligor and in all respects free from all defenses, setoffs and counterclaims both in law and equity, as is the lien of the Mortgage.

In all other respects, the Note hereinbefore described and all mortgages, documents and/or instruments securing the same shall remain unchanged and in full force and effect.
