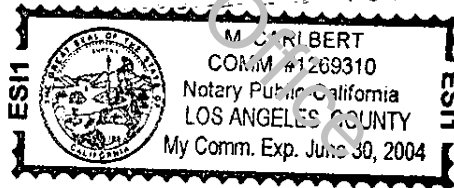

THIS MORTGAGE ("Security Instrument") is given on August 31, 1999. The mortgagor is:
