necessary for performance of its duties under the Agreement for the improvements to the Property.

3. All of the labor and materials furnished and delivered by Claimant were furnished to and used in connection with the improvement of the Property, and the last of such labor and materials was furnish, delivered and performed, and the work contemplated under the Agreement completed, on or about December 20, 2000

4. There is now justly due and owing to Claimant, after allowing to Owner all payments, credits, deductions and set-offs, the sum of Four Thousand Nine Hundred Dollars (\$4,900.00), plus interest at the rate specified in the Illinois Mechanics Lien Act, for the work performed on the Property.

5. Claimant now claims a lien on the above-described Property and all improvements thereon, against the Owner and all persons interested therein, for:

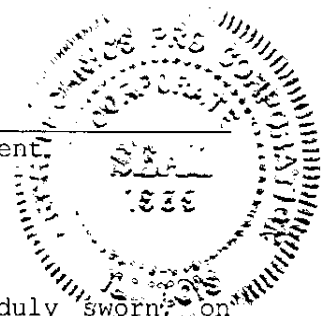
