THE SUM of ONE HUNDICED THIRTY SEVEN THOUSAND AND 00/100 Dollars (\$137,000.00) as evidenced by a note and mortgage executed and delivered on March 23, 1993, which said mortgage being recorded on March 25, 1993, i. Cook County, Illinois, as Document number 93221258 and

WHEREAS it is hereby agreed that for and in consideration of Ten and 00/100 Dollars (\$10.00) and other valuable considerations to the lender, the ubject mortgage will be modified. The current principal balance is \$87,684.26. The terms of this modification will be effective as of March 23, 2001 and will be as follows:

- 1. The interest rate remain a Fixed Rate Loan and will be fixed at 8.25%, for a consideration of .75% of a point or a sum of \$657.63.
- 2. Beginning with the first installment due under this Modification, April 23, 2001. The maturity date will be February 23, 2008 and will amortize over of months, the final payment amount to be verified by borrower prior to making the final payment.
- 3. Principal and interest payments will be \$1,377.61, beginning with the April 23, 2001 payment. The payment does not provide for escrows at this time.

The North ½ of Lot 23 and all of Lot 24 in Block 218 in Chicago Heights, a Section 29, Township 35 North, Range 14 East of the Third Principal Meridian, in Cook County, Illinois, according to the Plat thereof recorded July 30, 1894 as Document Number 2080510 in Book 63 of Place, Page 25 in Cook County, Illinois.
