- **B.** USE OF PROPERTY; COMPLIANCE WITH LAW. Borrower shall not seek, agree to or make a change in the use of the Property or its zoning classification, unless Lender has agreed in writing to the change. This assignment of Rents of the Property shall terminate when all the sums secured by the Security Instrument are paid in full.
