(3) That on 1/21, 2001, said contractor made an oral subcontract with the claimant to furnish material disposal receptacle(s) and material disposal services for and in said improvement, and that on 1/21, 2001, the claimant completed thereunder all required by said oral contract to be done, delivery and pick-up of material disposal receptacle(s) and the transportation thereof said material to a disposal site to the value of THREE HUNDRED THIRTY SEVEN (\$ 337 .00) Dollars.

(4) That said owner, or agent, architect or superintendent of owner
(a) cannot, upon reasonable diligence, be found in said County, or
(b) does not reside in said County.

(5) That said contractor is entitled to credits on account thereof as follows, to-wit:

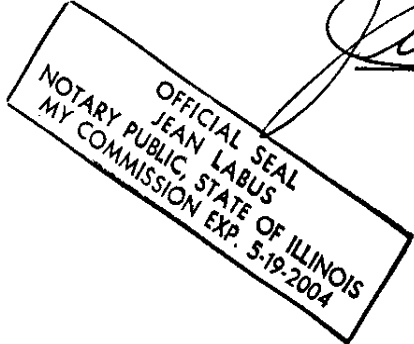
