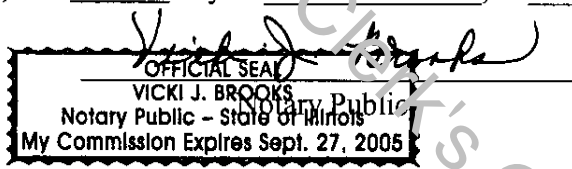

EXHIBIT "A"

LEGAL DESCRIPTION FOR PARK 1500 LOFT CONDOMINIUMS
