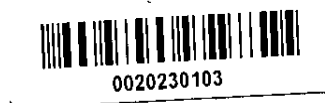

That the lien claimant furnished extra labor and materials to the Property for the agreed sum of \$8,000.00, and completed same on or about December 7, 2001.

That on or about December 7, 2001, the lien claimant completed all required work to be done by said contract including the agreed upon extra labor and materials.

The Owner is entitled to receive credits on account of the above in the sum of \$18,210.00.

That the balance due and owing to the lien claimant is the sum of \$4,690.00, for which amount the lien claimant hereby claims a Mechanics' Lien on the Property, land and improvements.


