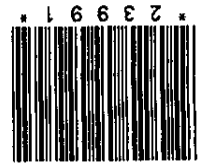
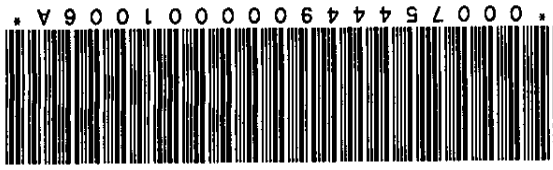

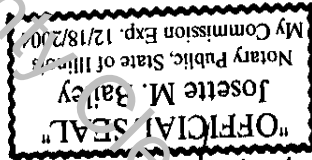
24. Waiver of Homestead. In accordance with Illinois law, the Borrower hereby releases and waives all charging of the fee is permitted under Applicable Law.
