Iment to Declaration of Cóndominium, dated as of September 24, 2001 and recorded in the Office of the Recorder of Deeds of Cook County, Illinois on September 25, 2001 as Document Number 5019893560; (iv) the Fourth Amendment to Declaration of Condominium, dated as of November 5, 2001 and recorded in the Office of the Recorder of Deeds of Cook County, Illinois on December 3, 2001 as Document Number 0011128923; and (v) the Fifth Amendment to Declaration of Conformium, dated as of December 11, 2001 and recorded in the Office of the Recorder of Deeds of Cook County, Illinois on December 17, 2001 as Document Number 0011197457, and (vi) the Sixth Amendment to Declaration of Condominium, dated as of January 3, 2002 and recorded in the Office of the Recorder of Deeds of Cook County, Illinois on January 10, 2002 as Document Number 0020041558 (collectively, the "Declaration"), is dated as of February 2002 ("Seventh Amendment") and is made by Heritage Club Villas, LLC, an Illinois limited liability company ("Declarant"), by its Manager, Raycorp, Inc., an Illinois corporation, pursuant to the

- A. Whereas, ARTICLE XVII, EXPANSIONS of the Declaration expressly reserves to Declarant the option to expand the Condominium Property.
- B. Whereas, Declarant is the owner in fee simple of all of the real property hereinafter described on the attached Exhibit A-2, and the improvements thereon and appurtenances thereto.
- C. Whereas, Declarant desires to expand the Condominium Property by adding to the Condominium Property the real estate legally described on the attached Exhibit A-2, and to make such addition subject to the Declaration and the Act.

Amendment

Now, therefore, the Declaration is hereby amended as follows:

1. ARTICIEI, THE LAND is hereby amended to read in its entirety as follows:

The Condemnium Property, located in the Village of Tinley Park, Cook County, Illinois, prior to the adoption of the Seventh Amendment to the Declaration, and is legally described on the attached Exhibit A-1. As of the date of the Seventh Amendment to the Declaration, the Condominium Property shall be expanded by adding the property owned by the Declarant and located in the Village of Tinley Park, Cook County, Illinois, and legally described on the attached Exhibit A-2, and depicted on the Survey, as shown on the attached Exhibit B.

- 2. The first sentence of ARTICLE IV, MPROVEMENT DESCRIPTIONS, Section
- 1. Residential Buildings. is hereby amended to read in its entirety as follows:
 - 1. There are sixteen (16) residential buildings which are a part of the Condominium, each containing four (4) dwelling Units, making a total of sixty-four (64) dwelling Units.
- 3. The first sentence of ARTICLE VI, COMMON AND LIMITED COMMON AREAS, Section 3. Undivided Interest. is hereby amended to read in its entirety as fcilov's:

The undivided interest in the Common Areas of each Unit is shown on the attached Amended and Restated Exhibit C.

4. The Declaration and this Seventh Amendment contain all of the terms, covenants, conditions and agreements of Declarant relating to the subject matter thereof and hereof. No prior or other agreements or understandings pertaining to such matters are valid or of any force and effect. Capitalized terms not defined herein shall have the meaning set forth in the Declaration.

5. To the extent of any inconsistency between the provisions of this Seventh Amendment and the Declaration, as amended, the provisions of this Seventh Amendment shall control. The Declaration, except as modified by this Seventh Amendment, is, in all respects, revived, republished, ratified and confirmed by the Declarant, and the terms, covenants, conditions and agreements thereof shall remain in full force and effect and binding upon all parties.
