INST AMENDMENT TO DECLARATION OF RESTRICTIONS

THIS FIRST AMENDMENT TO DECLARATION OF RESTRICTIONS (the "Amendment") is made and entered into as of this day of February, 2002 by Amalgamated Bank of Chicago, as Trustee under a Trust Agreement dated July 31, 2000 and known as Trust No. 5863 ("Declarant").

WITNESSETH:

WHEREAS, Declarant is the owner of that certain real property legally described on Attachment A attached hereto and made c part hereof ("Parcel A"); and

WHEREAS, Declarant is also the owner of that certain real property legally described on Attachment B attached hereto and made a part nereof ("Parcel B"); and

WHEREAS, Declarant has heretofore entered into that certain Declaration of Restrictions (the "Declaration") dated as of March 7, 2001 and recorded on March 12, 2001 in the Office of the Recorder of Deeds for Cook County, Illinois as document no. 0010192807, which Declaration imposes certain restrictions on Parcels A and B; and

WHEREAS, with the consent of the City of Calumet City, Declarant desires to amend the Declaration as provided in this Amendment.

NOW, THEREFORE, for and in consideration of Ten Dollars (\$10.06) in hand paid, and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, Declarant hereby amends the Declaration as follows: Exhibit B to the Declaration is hereby replaced in its entirety by the revised Exhibit B that is attached to and made a part of this Amendment as Attachment C, and consequently, from and after this Amendment, all references in the Declaration to "Parcel 2" shall mean and refer to the property described on Attachment C to this Amendment and the Declaration shall no longer apply to Lots 10, 11 and 12 referenced on Attachment B to this Amendment.

Except as provided in this Amendment, the Declaration remains in full force and effect without modification.

This Amendment shall be binding upon, and shall inure to the benefit of, Declarant and its successors and assigns.

It is expressly understood and agreed by and between the parties hereto, anything herein to the contrary notwithstanding, that each and all of the warranties, indemnities, representations, covenants, undertakings and agreements herein made on the part of the Trustee, while in form purporting to be the warranties, indemnities, representations, covenants, undertakings and agreements of said Trustee, are nevertheless, each and every one of them made and intended not as personal warranties, indemnities, representations, covenants, undertakings and agreements by said Trustee or for the purpose or with the intention of binding said Trustee personally but are made and intended for the purpose of binding only the trust property held by said Trustee, and this instrument is executed and delivered by said Trustee not in its own right, but solely in the exercise of the powers conferred upon it as such Trustee; and that no personal liability or responsibility is assumed by nor shall at any time be asserted or enforceable against Amalgamated Bank of Chicago on account of this instrument or on account of any warranty, indemnity, representation, covenant, undertaking or agreement of the said Trustee in this instrument contained, either expressed or implied, all of such personal liability, if any, being expressly waived and released.
