




## LEGAL DESCRIPTION

Parcel 1: That part of Lot 151 in Pheasant Lake Townhomes Unit 2, being a subdivision of part of the East Half of the Southeast Quarter of Section 34, Township 36 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois, being more particularly described as follows: commencing at the Northeast corner of aforesaid Lot 151; thence South 00 degrees 00 minutes 00 seconds West, along the East line of said Lot 151, 22.94 feet; thence South 90 degrees 00 minutes 00 seconds West, 112.21 feet to the point of beginning; thence South 00 degrees 00 minutes 00 seconds West 85.00 feet; thence South 90 degrees 00 minutes 00 seconds West 41.44 feet; thence North 00 degrees 00 minutes 00 seconds East 85.00 feet; thence North 90 degrees 00 minutes 00 seconds East 41.44 feet to the point of beginning, in Cook County, Illinois.
