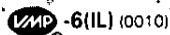

BORROWER COVENANTS that Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property and that the Property is unencumbered, except for encumbrances of record. Borrower shall pay to Lender on the day Periodic Payments are due under the Note, until the Note is paid in full, a sum (the "Funds") to provide for payment of amounts due for: (a) taxes and assessments and other items which can attain priority over this Security Instrument as a lien or encumbrance on the Property; (b) leasehold payments or ground rents on the Property, if any; (c) premiums for any and all insurance required by Lender under Section 5; and (d) Mortgage Insurance premiums, if any, or any sums payable by Borrower to Lender in lieu of the payment of Mortgage Insurance premiums in accordance with the provisions of Section 10. These items are called "Escrow Items." At origination or at any time during the term of the Loan, Lender may require that Community Association Dues, Fees, and Assessments, if any, be escrowed by Borrower, and such dues, fees and assessments shall be an Escrow Item. Borrower shall promptly furnish to Lender all notices of amounts to be paid under this Section. Any application of payments, insurance proceeds, or Miscellaneous Proceeds to principal due under the Note shall be applied first to any prepayment charges and then as described in the Note. More Periodic Payments, such excess may be applied to any late charges due. Voluntary prepayments shall be applied first to any prepayment charges and then as described in the Note. To the extent that any excess exists after the payment is applied to the full payment of one or more Periodic Payments, Lender may apply any payment received from Borrower to the repayment of the Periodic Payments if, and to the extent that, each payment can be applied to pay any late charge due, the payment may be applied to the delinquent payment and sufficient amount to pay any late charge due, the payment may be applied to the delinquent payment and then to reduce the principal balance of the Note.



22. Acceleration; Remedies. 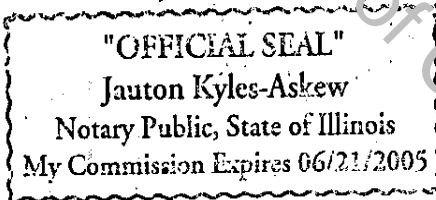
