10.

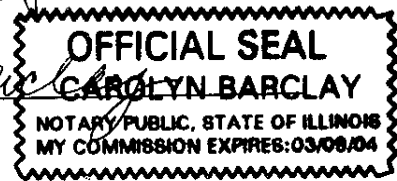
