

THIS ASSIGNMENT OF ASSIGNMENT OF LEASES AND RENTS (this "Assignment"), made and entered into this 19 day of February, 2002, is by SUN LIFE ASSURANCE COMPANY OF CANADA, a Canadian corporation, having an address of One Sun Life Executive Park, Wellesley Hills, Massachusetts 02481 ("Assignor"), in favor of CCG POOL NUMBER 2, INC., a Delaware corporation, having an address in care of Coventree Capital Group, Inc., Thomson Building, 65 Queen Street West, 10th Floor, Toronto, Ontario, Canada M5H 2M5 ("Assignee").

WITNESSETH

WHEREAS, Assignor made a loan in the stated principal amount of Five Million Three Hundred Fifty Thousand and 00/100 Dollars (\$5,350,000.00)(the "Loan") to SCHAUMBURG MARKETPLACE, LLC an Illinois limited liability company ("Borrower"), evidenced by a promissory note dated January 24, 2001 (the "Note") in connection with the financing of certain real property situated in the Courty of Cook and State of Illinois more particularly described on Exhibit A annexed hereto and made a part hereof (the "Premises"); and

WHEREAS, the Note is secured by, among other things, the Assignment of Leases, as defined on Exhibit B annexed hereto; and

WHEREAS, Assignor, as seller, and Assignee, as purchaser, have entered into that certain Seller Mortgage Loan Purchase Agreement cated substantially of even date herewith (the "Purchase Agreement"), whereby Assignor has agreed to convey to Assignee all of its right, title and interest in the Note, the Assignment of Leases and all other documents and agreements executed in connection with the Loan evidenced by the Note; and

WHEREAS, the parties hereto desire that Assignor assign to Assignee, its successors and assigns, all of Assignor's right, title and interest in and to the Assignment of Leases.

NOW, THEREFORE, in consideration of the premises above set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby aclar wledged and agreed, Assignor and Assignee hereby covenant and agree as follows:

1. <u>Assignment</u>. Assignor does hereby transfer, assign, grant, and convey to Assignee, its successors and assigns, all of the right, title and interest of Assignor in and to the document as identified and more particularly described in <u>Exhibit B</u> attached hereto, and does hereby grant and delegate to Assignee, its successors and assigns, any and all of the duties and obligations of Assignor from and after the date hereof.

- 2. <u>Representations and Warranties of Assignor</u>. This Assignment is an absolute assignment. This Assignment is made without recourse, representation or warranty, except as set forth in the Purchase Agreement.
- 3. <u>Governing Law</u>. This Assignment shall be governed by and construed in accordance with the laws of the State of New York.
- 4. <u>Successors and Assigns</u>. This Assignment shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.
- 5. <u>Headings</u>. The headings of the paragraphs of this Assignment have been included only for convenience, and shall not be deemed in any manner to modify or limit any of the provisions of this Assignment or used in any manner in the interpretation of this Agreement.
- 6. <u>Interpretation</u>. Whenever the context so requires in this Assignment, all words used in the singular shall be construed to have been used in the plural (and vice versa), each gender shall be construed to include any other genders, and the word "person" shall be construed to include a natural person, a corporation, a firm, a partnership, a joint venture, a trust, an estate or any other entity.
- 7. Partial Invalidity. Each provision of this Assignment shall be valid and enforceable to the fullest extent permitted by law. If any provision of this Assignment or the application of such provision to any person of circumstances shall, to any extent, be invalid or unenforceable, then the remainder of this Assignment, or the application of such provision to persons or circumstances other than those as to which it is held invalid or unenforceable, shall not be affected by such invalidity or unenforceability.
- 8. <u>Further Agreements</u>. Assignor agrees to execute and deliver to Assignee such additional documents, instruments or agreements as may be necessary or appropriate to effectuate the purposes of this Assignment.


