This Amendment No. 1 to the Declaration of Condominium Ownership and By-Laws Easements, Restriction and Covenants for the Mentor Building Condominium Association, ("Amendment") is made as of the 1st day of November, 2001, by the Mentor Building, L.L.C., an Illinois limited liability company ("Declarant").

WITNESSETH THAT

WHEREAS, Declarant made and entered into that certain Declaration of Condominium Ownership and By-Laws Easements, Restriction and Covenants for the Mentor Building Condominium Association, an Illinois not-for-profit corporation (the "Association"), recorded on June 24, 2001 with the Recorder of Deeds of Cook County, Illinois as Documen No. 10558080 ("Declaration");

WHEREAS, under the Declaration Unit 1602 is a "Combined Unit";

WHEREAS, pursuant to Article II, Section 1(d) of the Declaration, Declarant has the right to divide a Combined Unit into two "New Units" before transfer of control to the Association;

WHEREAS, Declarant hereby desires to divide Unit 1602 into two New Units and its respective Storage Space into two new Storage Spaces;

WHEREAS, the real estate as amended hereby is described in Exhibit A attached hereto and made a part hereof;
