1. Article Ten, Section 10.03 of the Declaration shall be amended as follows:

10.03 AMENDMENT BY UNIT OWNERS:

Subject to the provisions of Section 8.02 and 10.02 and except as otherwise provided in Sections 5.06 to 5.07 and the Act, the provisions of this Declaration may be amended, modified, enlarged or otherwise changed in whole or in part by the affirmative vote of Voting Members (either in person or by proxy), or by an instrument executed by Unit Owners, representing at least 66-2/3% 75% of the Undivided Interests; except that (i) the provisions relating to the rights of Declarant or Declarant's beneficiary may be amended only with the prior written consent of the Declarant and (ii) provisions relating to the rights of the Village of Palatine may only be amended with the prior written consent of the Village. No amendment shall become effective until Fecorded.

- 2. This Amendment shall be effective upon recordation in the Office of the Recorder of Deeds of Cook County, livinois.
- **3.** Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.
