1. The distance and bearings of the common line between Lot 28 and lot 29 shall be North 89 degrees 06 minutes 12 seconds West, 141.48 feet.
2. There is a 20' building setback line along the north side of Lot 27.
3. There is a 20' building setback line along the south side of Lot 26.
4. The bearings for the West line of Lots 33 through 43 inclusive, shall be North 00 degrees 53 minutes 48 seconds East.
5. The bearings for the West line of Lots 55 through 57 inclusive, shall be North 00 degrees 53 minutes 48 seconds East.
6. There is a 20' building setback line along the north side of Lots 1 through 5 inclusive.

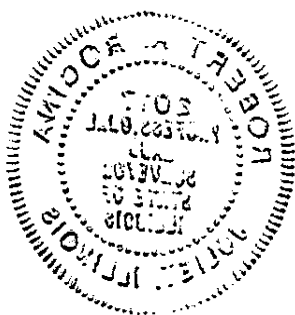
